01 GENERAL

- This Hospitality Rider forms an integral part of the agreement between the Organizer and Feral Agency.
- All requirements must be confirmed in writing in advance.

02 CATERING

The Organizer must provide adequate catering for the artist and crew, available before, during and after the performance:

03 EQUIPMENT SECURITY AND SAFETY

- The Organizer is responsible for the safety of all equipment, sound media and personal belongings of the artist, as well as the artist's personal safety during the event.
- A secure, lockable space must be provided for storing equipment and belongings.
- The Organizer is liable for any damage, theft or loss of equipment and belongings, and for injury or health issues affecting the artist. Adequate insurance must be in place.

04 AVAILABILITY

- The Organizer must be available during the soundcheck and the performance.

05 PERMITS AND APPROVALS

- The Organizer must obtain all necessary permits, licenses and approvals (including liability insurance, fire safety, dance permits, PR, PPL and alcohol licenses) required for the event.
- The Organizer covers all costs related to visas, PCR tests, work permits or other documents required for the artist to perform at the agreed location, provided in good time.

06 RECORDINGS

- No recording of the artist during the soundcheck or performance may be made without prior written consent from Feral Agency or the artist.
- Any authorized recording may not be broadcast, published or made public without prior written consent.

07 LIABILITY AND COMPLIANCE

- Liability and compliance are subject to the agreement between Feral Agency and the Organizer.
- In case of disputes or irregularities, Feral Agency must be contacted directly.

08 TRAVEL AND ACCOMMODATION

- All travel, accommodation and related expenses are outlined in the contract.
