Contracting party: Clear Agency VOF, Druivenstraat 55, 4816 KB Breda, the Netherlands, trading as Clear Agency and Feral Agency.

01 General

- This Hospitality Rider forms an integral part of the agreement between the organizer and Clear Agency, the exclusive representative of the artist.
- All requirements must be confirmed in writing beforehand. If any conditions cannot be met, this must be communicated to Clear Agency or the artist in a timely manner.

02 Catering

The organizer must provide adequate catering for both the artist and their guests, available before, during, and after the performance. Catering includes:

1x	Bottle of Grey Goose Vodka or Belvedere Vodka.
6x	Cans of Stelz (Ice Tea Peach, Ice Tea Lemon or Strawberry Lemonade).
1x	Pack of Marlboro Gold cigarettes.
4x	Cans of Red Bull.
4x	Cans of Fanta or Sprite.
	Still and sparkling water available on stage during the performance.
	A selection of snacks available backstage.
	The organizer must provide a meal appropriate to the timing of the performance. Breakfast: for morning events. Lunch: for afternoon events. Hot meal: for evening or nighttime events.

03 Equipment Security and Safety

- The organizer is responsible for the safety of all equipment, sound media, and personal belongings of the artist, as well as the artist's personal safety during the event.
- A secure, lockable space must be provided for storing equipment and belongings.
- The organizer is liable for any damage, theft, or loss of equipment and personal belongings, as well as for injury or health issues affecting the artist. Adequate insurance must be taken out to cover these risks.

04 Availability

- The organizer must be available during the soundcheck and performance.

05 Permits and Approvals

- The organizer must obtain all necessary permits, licenses, and approvals (including liability insurance, fire safety, dance permits, PR, PPL, and alcohol licenses) required for the event.
- The organizer is responsible for all costs related to visas, PCR tests, work permits, or other documents required for the artist to perform at the agreed location. These must be provided in a timely manner.

06 Recordings

- No recordings of the artist during the soundcheck or performance may be made without prior written consent from Clear Agency or the artist.
- Any authorized recordings may not be broadcast, published, or made publicly available without prior written consent.

07 Liability & Compliance

- Liability and compliance are subject to the terms outlined in the agreement between Clear Agency and the organizer.
- In case of disputes or irregularities, Clear Agency must be contacted directly.

08 Contract

- All travel, accommodation, and related expenses are outlined in the contract.
